LICENSING AGREEMENT

This document is a legal agreement between you, the end user, and Authors. By obtaining and/or installing delivered software, you agree to the terms and conditions set forth in this Agreement.

1. TERMS AND DEFINITIONS

1.1 "Font Software" (hereinafter "Font"): Any font in any digital format.

1.2 "Basic Web License": A license that grants to a user of purchased Font the set of rights listed in this Licensing Agreement.

1.3 "Additional Web License": An extension to the Basic Web License that confers additional rights, such as the right to use the Font in interactive Web applications, the right to modify the Font, etc.

2. GRANT OF LICENSE AND RESTRICTIONS

2.1 Traffic Limitations

You may use the Font on Web servers that belong to you and that were specified at the time of purchase, with the condition that the total traffic on these Web servers does not exceed the number of pageviews specified in the purchase documents. If you do not have such documents, you may only use the Font on one server, and total traffic on this server must be no greater than 10000 pageviews per month.

2.2 Font Usage

You may use the Font for texts on your Web sites using the @font-face selector in CSS files under the condition that you place the information about Font copyright and Brownfox into a source code of your pages in the same way as shown in the sample HTML/CSS/Javascript files provided with the Font.
